## **Description:**

This course is intended to provide an effective way to submit voluntary deductions for mass entries into FPPS. This interface file eliminates the need for manual input and allows deductions to be sent on a file that is directly loaded to FPPS. This webinar will instruct clients on how to use the Voluntary Deduction File and how to view the Voluntary Deduction File Load Error Report (PYRL0184). The Voluntary Deduction file can be used for the following pay codes:
